- m. To appoint and/or dismiss officers or other employees to look after and manage the properties constituting the Trust Fund and to allot to such persons such duties the trustees may think fit and proper.

- o. To join, co-operate or amalgamate this Trust with other Trust or Fund having kindred or allied objects upon such terms and conditions as the Trustees may in their discretion think fit.

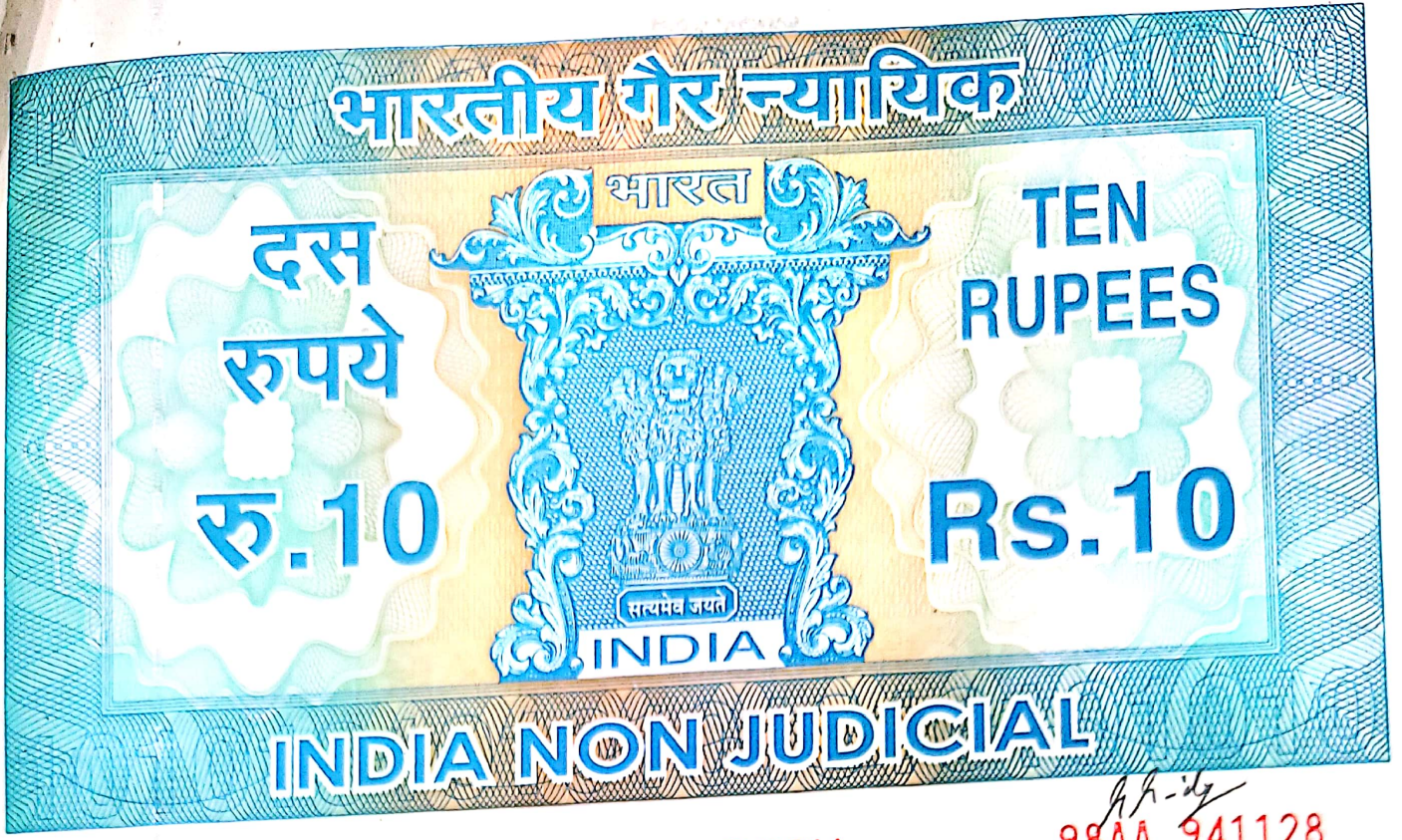

 - s. To withdraw any power or revoke any appointment of any employee or attorney

7. TRUSTEES:

- a. A person shall be qualified to become a trustee only if he follows the following principles both, in his public as well as his private life and shall be disqualified to continue as a trustee if he is found violating the following principles:
 - i. He shall not take any intoxicants, ii. He shall not smoke; iii. He shall not gamble and iv. He shall not have illicit relation.
- b. The Trustees appointed under this deed will be for life, provided they follow the rules and regulations of the trust, otherwise the trustee shall be removed from the trust by not less than 2/3rd of the trustees present in that trustees meeting with sufficient quorum
- c. The trustees will be at liberty to appoint additional Trustees in the meeting with sufficient quorum. Any Trustee may resign by giving notice in writing to his co-trustees.
- d. A person shall cease to be a trustee, if he without leave of absence, does not attend three consecutive meetings of the trustees or for one calendar year whichever is longer, or he is requested to resign by all other trustees in writing.
- e. If any trustee resigns, dies, retires, becomes unfit or incapable to act, the continuing or surviving trustees will be competent to appoint trustee in place of the trustee resigning, dying retiring or becoming unfit or incapable to act either for life or otherwise as a foresaid.
- f. A trustee may delegate in writing all or any of his powers to his nominee who will be entitled so long as such nomination remains in force to exercise such power or powers in the same manner as the trustee himself could do personally.
- g. He without leave of absence does not attend three consecutive Meetings of the trustees or for one calendar year whichever is longer, or he is requested to resign by all other trustees in writing.

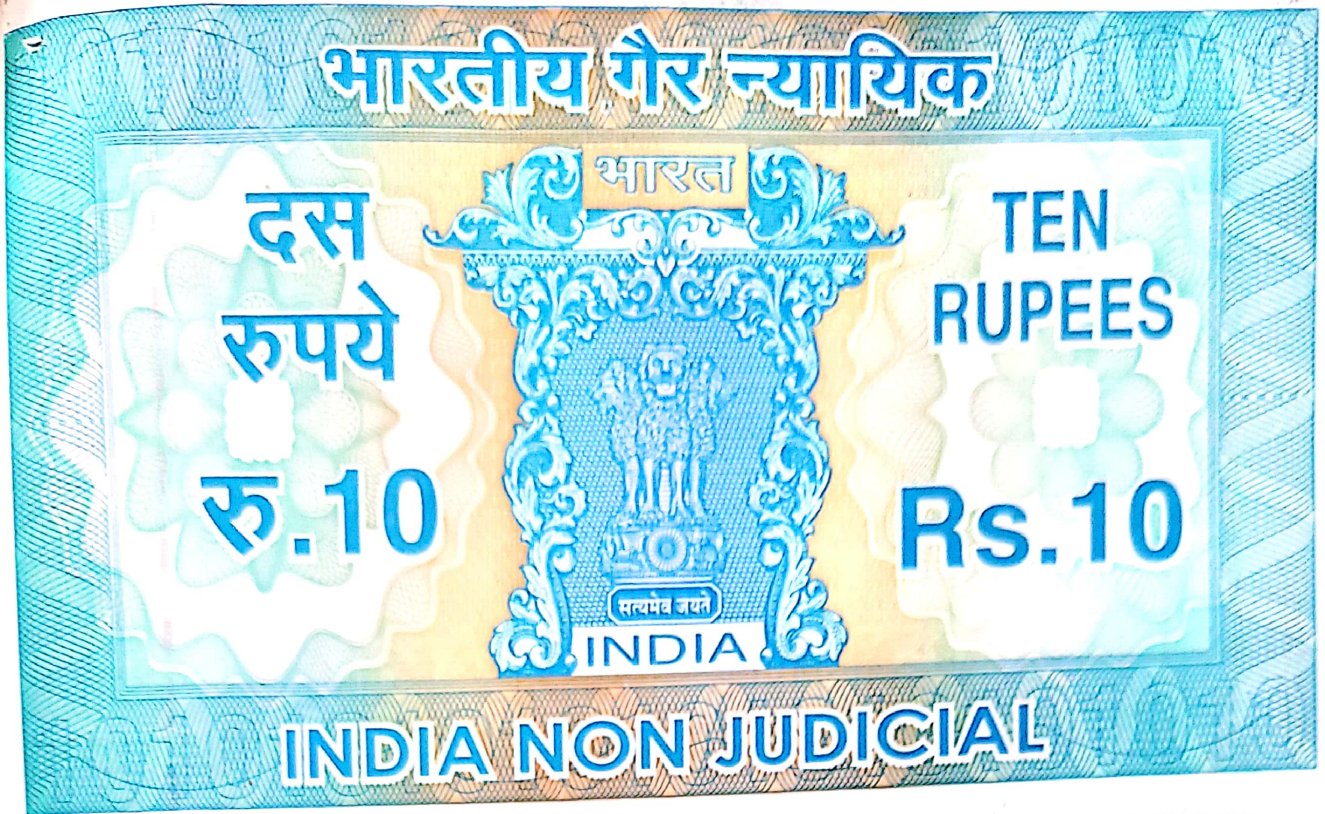
12. DISSOLUTIONS:

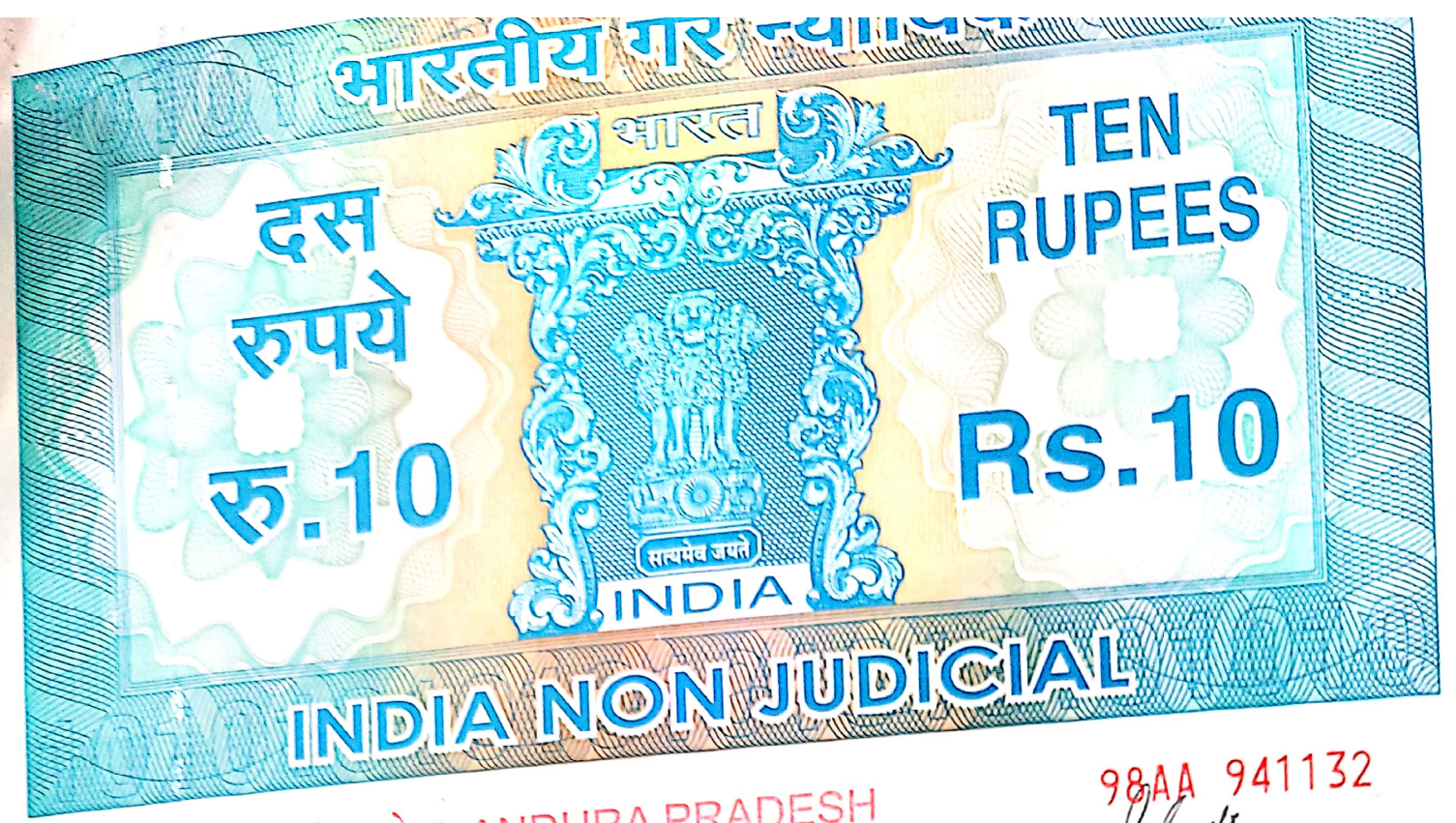

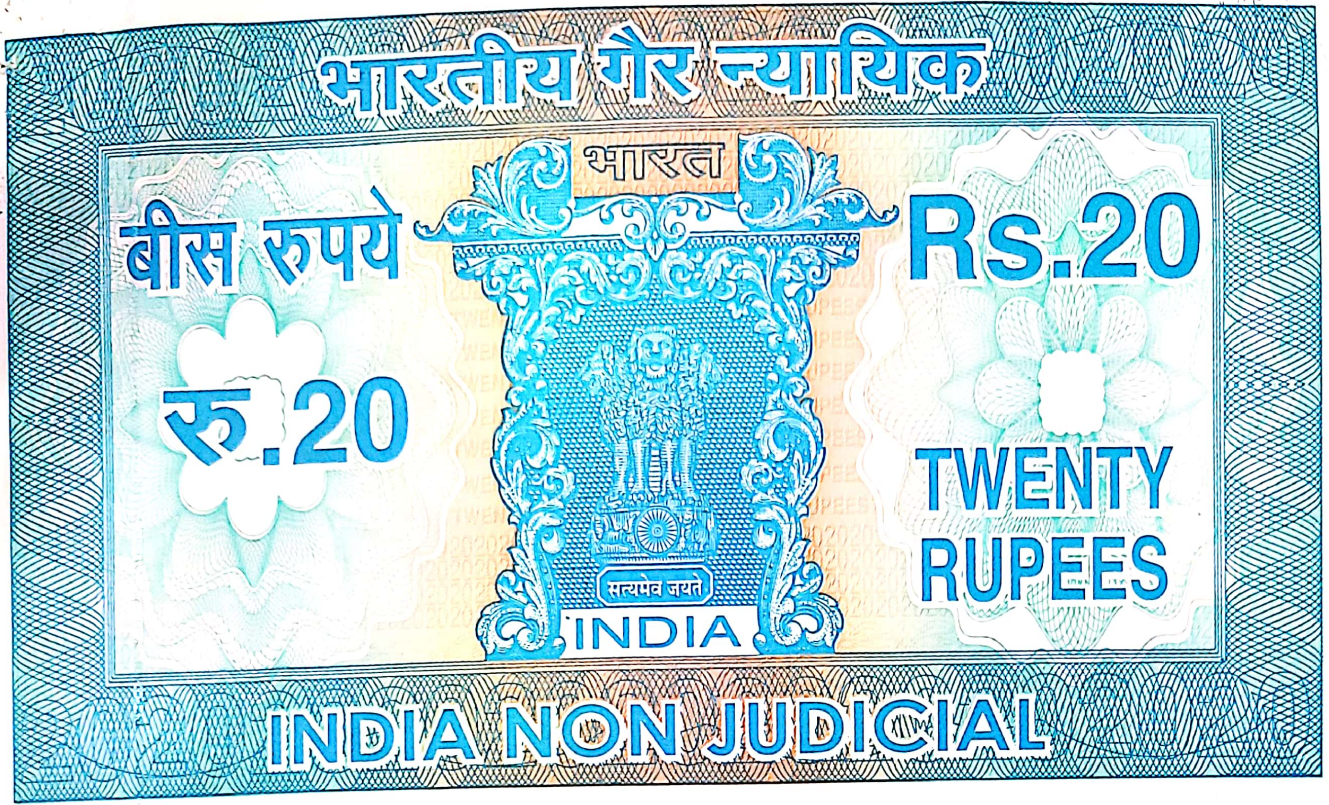
